

**Assigned Puppy/Dog Confirmation Agreement**

This agreement (“**Agreement**”), dated as of \_\_\_\_\_, 20\_\_ (the “**Effective Date**”), is between Vanessa Sharp/O’So Sharp, LLC (“**Breeder**”), and \_\_\_\_\_ (“**Buyer**”). The subject of this Agreement is the below-described puppy/dog (“**puppy/dog**”).

The Breeder and Buyer agree as follows:

1. **Assigned Puppy.** The above described puppy/dog is assigned to the Buyer as of the date of this agreement. If at any time, the Breeder determines I am no longer a good fit for the assigned puppy/dog prior to the final Puppy/Dog Purchase Agreement, the Breeder has the right to return my full Deposit amount.
  - a. If the Buyer at any point after execution of this agreement no longer chooses to purchase a puppy/dog from the Breeder, the Breeder has the right to keep the Deposit in full.
  - b. If the Breeder is unable to make contact with me after ten (10) days of reasonable attempts, the Breeder has the right to treat my Deposit as abandoned and keep the Deposit in full and the assigned puppy/dog will be assigned to another Buyer.
2. **Deposit.** A non-refundable deposit of \$500 (“**Deposit**”) has been paid to Breeder to secure this puppy/dog. The Deposit shall be applied to the final Purchase Price of this specific puppy/dog and is defined below. Buyer acknowledges that the Deposit is non-refundable in all circumstances upon execution of this agreement as defined above.
3. **Purchase Price.** The above puppy/dog is \$2,000 (“**Purchase Price**”) is agreed with the balance due in full (a) at least 3 weeks prior to the time the puppy/dog is delivered to Buyer or (b) upon Buyer’s pickup of the puppy/dog. Any shipping and handling expenses are the responsibility of and shall be paid by Buyer. All payments due under this Agreement shall be made in US Dollars and paid to Breeder via Payments through Good Dog (<https://pay.gooddog.com/oso-sharp-dogs>) or cash or cashier’s check.
4. **Puppy/Dog Purchase Agreement & Guarantee.** The Buyer and Breeder acknowledge the current terms and conditions of the Puppy/Dog Purchase Agreement & Guarantee as provided by Breeder on OsoSharpDogs.com. This contract is subject to change at any time at the discretion of the Breeder, but any changes will be communicated to the Buyer prior to final agreement and execution. The Puppy/Dog Purchase Agreement and Guarantee will be executed at the time of (a) puppy/dog delivery to Buyer or (b) upon Buyer’s pickup of the puppy/dog.
